

WOODWORKING NETWORK “SHOP SMARTS CHALLENGE” CONTEST

OFFICIAL RULES

- **NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER THIS CONTEST. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF RECEIVING A PRIZE.**
- **VOID WHERE PROHIBITED BY LAW.**
- **ADMINISTRATOR AND EACH SPONSOR OBTAINS A NON-EXCLUSIVE LICENSE TO POST AND USE ANY AND ALL CONTENT SUBMITTED AS PART OF THE CONTEST.**
- **ONLY ONE ENTRY PER ELIGIBLE PARTICIPANT**

BY ENTERING/PARTICIPATING IN THE CONTEST, YOU MUST AGREE TO THESE OFFICIAL RULES, WHICH CREATE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, SUCH CONTRACT INCLUDES GRANTS OF RIGHTS AND INDEMNITIES TO THE ADMINISTRATOR AND EACH SPONSOR FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Woodworking Network’s “Shop Smarts Challenge” Contest (the “Contest”) is open only to legal residents of the 50 United States, including the District of Columbia, who are 18 years of age or older at time of entry. Employees, officers and directors of Woodworking Network, and any of its parent companies, subsidiaries, affiliates, representatives, franchisees, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment, and marketing agencies, web site providers, web masters, and members of their immediate families (spouses, parents, children, siblings and their spouses, regardless of where they live) and those living in the same household are not eligible to enter. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and to Sponsor’s decisions, which are final and binding in all matters related to the Contest. Receiving a prize is contingent on fulfilling all requirements set forth herein. Administrator and/or the Sponsor reserve the right to verify the eligibility of winner. Void where prohibited by law. Subject to all federal, state and

local laws, regulations, and ordinances.

2. **ENTRY PERIOD:** The Contest begins at 12:00 a.m. Eastern Daylight Time (“EDT”) on Tuesday, December 1, 2015 and ends at 11:59 p.m. EDT on Thursday, December 31, 2015 (the "Contest Period"), or while supplies last. Administrator's computer clock is the official time-keeping device for the Contest. The Administrator and/or Sponsor may at its discretion shift the Contest Period and/or any terms of the Contest and post notice of shift online at <http://www.woodworkingnetwork.com/shopsmarts>.

3. **HOW TO ENTER CONTEST:** Participants will go to <http://www.woodworkingnetwork.com/shopsmarts> to enter the contest. When prompted participants will share their contact information including shipping address. Participants must enter a valid address to participate. Participants must be able to provide such information in a form acceptable to the Administrator and/or Sponsor.

LIMIT: One (1) entry per household. Submissions generated by script, macro or other automated means are void.

Contest entries will be attributed to the authorized account holder of the email address submitted during registration/entry. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address used to enter will be deemed to be the registrant or participant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider, Internet service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Participants may be required to provide the Administrator and/or

Sponsor with proof that the recipient is the authorized account holder of the email address associated with the entry, or forfeit the prize. Entries specifying an invalid, non-working, or inactive email address will be disqualified and ineligible to win.

All entries become the property of the Administrator and will not be returned or acknowledged, and Administrator will not verify receipt of entries.

4. **PRIZE:** Prize varies between contests, at this time the winner(s) may be featured on WoodworkingNetwork.com and in the printed publication.
5. **PRIZE CONDITIONS AND RESTRICTIONS:** The prize is not transferable and no substitution is allowed except in Administrator's sole discretion. Prize may not be redeemed for cash. Administrator reserves the right to substitute prize of equal or greater value if advertised prize (or portion of prize) is unavailable. Winner is responsible for any loss of prize or portion of prize after it has been delivered. Administrator will not replace any lost or stolen prizes. All federal, state and local tax liabilities are the responsibility of the winners. Acceptance of a prize constitutes permission (except where prohibited) for the Administrator to use the winner's name, likeness, biography, statements, and any other similar materials for marketing and publicity purposes without additional compensation or limitation.
6. **GENERAL CONDITIONS:** If, for any reason, the Contest is not able to run as planned, including infection by computer virus or bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Administrator which corrupt or affect the operation,

administration, security, fairness, integrity, or proper conduct of this Contest, Administrator may, in its sole discretion, void any suspect entries and: (a) cancel, suspend, or terminate the Contest (or any portion thereof); (b) modify the Contest or suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules; and/or (c) award the prize from among the eligible entries received, up to the time of impairment.

Administrator reserves the right at its sole discretion to disqualify any individual it finds to be attempting to tamper with or undermine the entry process and/or the legitimate operation of the Contest; to violate the Official Rules; or to act in an unsportsmanlike or disruptive manner or with the intent to annoy, abuse, threaten, or harass any other person. Entrants agree that Administrator shall own the entries, which shall not be acknowledged or returned.

The Sponsor and any and all Internet server(s) and access provider(s) (collectively: "Promotion Entities"), and each of their respective affiliates, subsidiaries, parent corporations, advertising and promotional agencies, and all of their officers, directors, shareholders, employees and agents (collectively with the Promotion Entities, the "Releases") are not responsible for: any incorrect or inaccurate entry information; human errors; technical malfunctions; failures, omissions, interruptions, deletions or defects of any telephone network, computer online systems, computer equipment, servers, providers or software, including without limitation any injury or damage to participant's or any other person's computer relating to or resulting from participation in the Contest; inability to access the Entry Site; theft, tampering, destruction, or unauthorized access to, or alteration of, entries; data that is processed late or incorrectly or is incomplete or lost due to telephone, computer or electronic malfunction or

traffic congestion on telephone lines or the Internet or any website (including the Entry Site) or for any other reason whatsoever; printing or other errors; any entries which are late, lost, incomplete, misdirected, stolen, mutilated, illegible, or any combination thereof. Illegible and incomplete entrants are ineligible. By entering the Contest, entrants affirm that they have read and accepted these Official Rules. Any entry information collected through the Contest shall be used only to administer the Contest in accordance with these Official Rules.
